WHEREAS the Ontario For tage act. 1974, authorizes the Council of a Nunicipal to enact by-laws to designate real property, ding all the buildings and structures thereon, to be of historic or architectural value or interest; and

WHEREAS the Council of 'he Corporation of the Township of Bastard and South Burge 3 has caused to be served upon the owner of the lands an premises known as "Old Stone Mill" Village of Delta, up n the Ontario Heritage Foundation notice of intention to a designate the aforesaid real property and has caus i such notice of intention to be published in a newspape having a general circulation in the Municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedule "B" hereto; and

WHEREAS no notice of objection to the said proposed designation has been served upon the Clerk of the Municipality:

THEREFORE, the Council of the Corporation of the Township of Bastard and South Birgess enacts as follows:

- 1. There is designated as being of architectural value or interest the real property more particularly described in Schedule "A" here to, known as "Old Stone Mill", Village of Delta.
- The Township Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land Registry Office.
- 3. The Township Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general ci cutation in the Township of Bastard and South Burgess.

ALL AND SINGULAR that a rtain piece of land or tract of land situate, lying and bein, in the Village of Delta, in the Township of Bastard in the County of Leeds and being composed of part of Lot Number Ten (10) in Block "P" according to Beatty's Compiled Plan of the said Village of Delta registered in the Registry Office for the Registry Division of the County of Leeds as Plan 1. 153, and part of Mill Creek shown on said Plan and being part of Township Lot Number Twenty-Three (23) in the Ninth (9) Concession of the said Township of Bastard, now within the confiner of the Village of Delta, more particularly described as 1 0005, that is to say:
