# NOTICE OF INTENTION TO DESIGNATE

of the Township of Bastard and South Burgess intends to designate the property, including lands and buildings, at the following municipal address as property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, 1980 R. S. O., Chapter 337.

ALEXANDER STEVENS HOUSE: Part Lot One (1), Sixteen (16), Seventeen (17), Eighteen (18), and Nineteen (19), in Bock "C", according to Beatty's Plan 153 of the Village of Delta, and is present-vined by Mr. and Mrs. Robert Peabody.

REASON FOR DESIGNATION: This is a twostorey brick house, with a one-storey gabled wing at the rear. The medium hipped truncated roof has a flat section crested with decorative iron. The roof trim includes projecting eaves and frieze. Windows have segmental structural openings and are crowned with stone voussoirs and a keystone, as is the offset door. Both the open, one-storey porch and the extensive side porch are embellished with decorative trellis work.

ANY PERSON MAY, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Township of Bastard and South Burgess notice of his or her objection to the proposed designation, together with a statement of the reason for the objection and all relevant facts. If such Notice of Objection is received, the Council of the proposed of the Township of Bastard and South Burgess shall refer the matter to the Conservation Review Board for a hearing.

AND MRS. ROBERT PEABODY, AS A DESIGNATED PROPERTY UNDER THE ACT. WHEREAS the Ontario Heritage Act, 1974 authorizes the Council of a Municipality to enact by-laws to designate real property, including all the building and structures thereon, to be of historic or architectural value or interest; and

> WHEREAS The Council of the Corporation of the Township of Bastard and South Burgess has caused to be served upon the owner of the lands and premises known as the Alexander Stevens House, Part Lot One, Sixteen, Seventeen, Eighteen and Nineteen, in Block "C" Plan 153, Village of Delta, upon the Ontario Hertiage Foundation notice of intention to so designate the aforesaid property and has caused such notice of intention to be published in a newspaper having a general circulation in the Municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedule "B" hereto; and

WHEREAS no notice of objection to the said proposed designation has been served upon the Clerk of the Municipality;

THEREFORE, The Council of the Corporation of the Township of Bastard and South Burgess ENACTS AS FOLLOWS:

- There is designated as being of architectural value or interest the real property more particularly described in Schedule "B" hereto known as the Alexander Stevens House, Part Lot One (1), Sixteen (16), Seventeen (17), Eighteen (18), and Nineteen (19), in Block "C", Plan 153, Village of Delta.
- The Township Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Sechedule "A" hereto in the proper Land Registry Office.
- The Township Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foudnation and to cause notice of this by-law to be published in a newspaper having general circulation in the Township of Bastard and South Burgess.
