PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting a minor variance from the provisions of the Township of Rideau Lakes' Zoning By-law #2023-50 as amended. The applicants are proposing to construct a 55.58sqm (598.3sqft) 1 storey rear addition to an existing 165.55sqm (1782sqft) 1.5 storey dwelling. The existing dwelling is non-conforming with the required 30m water setback at a water setback of 21.55m (70.7ft), as well as non-conforming with the interior side yard setback (north) at a setback of 5.57m (18.29ft). The proposed addition will meet the 30m water setback, and will be located closer to the side lot line (north) than the existing dwelling. The following variance is requested:

• **Section 5.2.2** – Relief of 2.1m from the required minimum 6m side yard setback (north) to allow for 3.9m side yard setback for the proposed addition.
