PURPOSE: This is an application under Section 45 of the Ontario Planning Act requesting minor variances from the provisions of the Township of Rideau Lakes' Zoning By-law #2023-50 as amended. The applicants are proposing to construct a 660sqm (7104sqft) 2 storey dwelling with a footprint of 330sqm (3552sqft) which includes an attached garage. The following variances are requested:

- **Section 3.30.2** Relief of 14.6m from the required minimum 30m water setback to allow for 15.4m water setback for the proposed dwelling.
- **Section 11.1.2** Relief of 2.9m from the required minimum 7.5m rear yard setback to allow for 4.6m rear yard setback for the proposed dwelling.
- **Section 3.7 –** Relief of 2m from the required minimum 17.5m centreline of the Township street setback to allow for a 15.5m centreline of the Township street setback for the proposed dwelling.
