**TAKE NOTICE** that the Planning Advisory & Committee of Adjustment of the Council of the Corporation of the Township of Rideau Lakes will hold a public meeting on the **8th day of January, 2025**, **at 1:00pm** to review an application to amend the Township of Rideau Lakes' Zoning By-law #2023-50.

The request is to change the zoning classification on a portion of the subject property from Rural (RU) to General Commercial (CG), and a portion of the subject property from Rural (RU) to Rural Special Exception (RU-X) to permit a reduced interior side yard setback for the existing 15,000sqft storage building. This is related to draft approved consent application B-91-24. This application also requests a change the zoning classification on a portion of the subject property from Rural (RU) to General Commercial with a holding provision (CG-h) that is to restrict future development on the lot until a completed Site Plan Control application is approved and any necessary plans/studies are submitted which include, but are not limited to, a traffic impact study, illumination plan, and a stormwater management plan. This is related to draft approved consent application B-92-24. and applies to the proposed severed lands while excluding the retained lands.

The proposed Zoning By-law Amendment public meeting required under Section 34 of the Planning Act will take place at the Township's municipal offices at **1439 County Rd 8**, **Delta, Ontario, K0E 1G0**.

**TAKE NOTICE** that the Township of Rideau Lakes has determined this application to be complete under Section 34 (10.7) of the Planning Act.

**ANY PERSON** may attend the public meeting(s) and/or make written or verbal representation either in support of or in opposition to the proposed amendments.

If a person or public body would otherwise have an ability to appeal the decision of the Township of Rideau Lakes to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Corporation of the Township of Rideau Lakes to the Ontario Land Tribunal.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Rideau Lakes before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
